PUBLICATION OF EXPLANATORY SUMMARY OF THE SOUTH AFRICAN JUDICIAL
EDUCATION INSTITUTE AMENDMENT BILL, 2025**

1. Notice is hereby given in terms of Rule 276(1)(b) of the Rules of the National Assembly that the Minister of Justice and Constitutional Development intends to introduce the South African Judicial Education Institute Amendment Bill, 2025 (Bill), in the National Assembly shortly.
2. The explanatory summary of the Bill is hereby published in accordance with Rule 276(1)(c) of the Rules of the National Assembly.
3. The Bill seeks to amend the South African Judicial Education Institute Act, 2008 (Act No. 14 of 2008) in order to—
 - (a) provide for the appointment of a judge as the Dean to serve as the academic head of the Institute;
 - (b) provide for the powers and duties of the Dean;
 - (c) further clarify the appointment process for the Executive Director and powers and duties of the Executive Director; and
 - (d) provide for the reimbursement of members of the Institute for subsistence and travelling expenses.

1. Kragtens Reël 276(1)(b) van die Reëls van die Nasionale Vergadering word hierby kennis gegee dat die Minister van Justisie en Staatskundige Ontwikkeling beoog om die Wysigingswetsontwerp op die Suid-Afrikaanse Regterlike Opleidingsinstituut, 2025 (Wetsontwerp), eersdaags in die Nasionale Vergadering in te dien.
2. Die verduidelikende opsomming van die Wetsontwerp word hierby ooreenkomstig Reël 276(1)(c) van die Reëls van die Nasionale Vergadering gepubliseer.
3. Die Wetsontwerp beoog om die Wet op die Suid-Afrikaanse Regterlike Opleidingsinstituut, 2008 (Wet No. 14 van 2008) te wysig ten einde—
 - (a) voorsiening te maak vir die aanstelling van 'n regter as die Dekaan om as die akademiese hoof van die Instituut te dien;
 - (b) voorsiening te maak vir die kragte en pligte van die Dekaan;
 - (c) verder die aanstellingsproses vir die Uitvoerende Direkteur en die kragte en pligte van die Uitvoerende Direkteur te verduidelik; en
 - (d) voorsiening te maak vir die vergoeding van lede van die Instituut vir bestaans- en reisuittgawes.
4.
